The undersigned brothers, all being leading brothers in the churches in the south central part of the United States, wish to strongly affirm our agreement with the entirety of the recently released statement entitled *"A Warning to all the Saints and all the Churches in the Lord's Recovery Concerning Titus Chu and those who Promote and Disseminate his Divisive Teachings, Publications, Practices and Views (October 1, 2006)."*

We, as leading brothers and overseers of the churches in this area, appreciate the leadership in the Lord's recovery today and this healthy letter of inoculation and warning to all the saints. We firmly agree with the blending co-workers in taking the grave action of quarantining Titus Chu and certain of his co-workers because of their divisive speaking and working. We agree that this action is in accordance with Romans 16:17 and Titus 3:10.
